### KEY FEATURES

Each unit is equipped with the base features described below. Our Sentry units are equipped with three (3) dome camera, creating a tri-camera system with a 270° total field of view.

- Intrusion detection with two (2)-way, one (1)-click horn speaker.
- High-efficiency solar panel with up to 100 watts of power.
- Dual LED light panes with dusk to dawn operation.
- Operational storage with built-in battery monitor and LiFePO4 battery for 24/7 operation.
- Dome camera with 5MP image sensor, 128° field of view, and near 100-foot object detection.
- Wireless router and Air Card.
- Rapid deployment with 4G connectivity, eliminating the need for Wi-Fi connection.
- Two (2) alternating LED strobe panels for deterrence.

## MONITORING FEATURES

---

Standard monitoring services consists of the four levels below.  
Customized monitoring can be added for additional monthly fees.

<b>Incident-based monitoring</b>	After-hours monitoring of incident-based alerts through the TSOC. After-hours is considered 6:00 PM to 6:00 AM on weekdays and weekends 24 hours. Regular weekend business hours excluded if applicable.
<b>After-Hours Virtual Tours</b>	Virtual property tours conducted twice (2) every night of the week between 6:00 PM and 6:00 AM, and twice (2) per day during weekends between 6:00 AM and 6:00 PM. Analysts monitor and report any suspicious activity.
<b>Passive monitoring</b>	Cameras still record and capture information during regular weekday business hours (6:00 AM to 6:00 PM) when not monitoring on virtual tours. If evidentiary documentation is required, information will be provided upon request.
<b>Defined Incident monitoring</b>	Site is monitored for specific events ("defined incidents") during business hours. Common defined incidents include, but aren't limited to, motion detection in secured spaces and vehicle or person(s) of interest detection.

## ARTIFICIAL INTELLIGENCE

### Standard features include:

- **People Analytics**– filter detected faces and view objects individuals may be carrying while in a defined area.
- **Vehicle Analytics**– browse, cross-search, and filter snapshots of vehicles detected within a defined area. Filters are available for a range of attributes, including vehicle body type and color.
- **Interest Notifications**– create triggers and set proactive alerts when a Person or Vehicle of Interest enters or exits the camera's field of view. Manual voice commands through horn speaker included.
- **Motion Notifications**– trigger an alert when people are in a defined space within a certain time window.

### Optional features<sup>1</sup> include:

- **24-Hour History View (Time Lapse)**– our Analysts can quickly view an entire day's worth of footage and find meaningful events, including people and vehicles instead of spending days manually scrubbing through hours of video.
- **License Plate Recognition (LPR)**– differentiate and categorize objects and license plates from up to 98' away with best-in-class LPR technology. Full video image can be viewed in up to 4K resolution along with tagged attributes and metadata.
